- 7. If the amount shown to be payable on each Tax Invoice and / or statement of account is not paid to Outback Cleaning Products on or before the Due Date such amount will be deemed to be overdue and Outback Cleaning Products at its discretion, impose an invoice late payment fee of \$30.00. Interest will also be charged at the rate equivalent to the advertised compound interest rate charged by the NAB Bank and to be compounded monthly.
- 8. Any expenses, cost or disbursement incurred by Outback Cleaning Products in recovering any outstanding monies including debt collection fees and solicitor costs shall be paid by the Customer, providing that thosefees do not exceed the scale charges as charged by that debt collection agency/solicitor plus any out of pocket expenses.
